Sub: Ensuring 100% implementation of e-MRO Portal for remittance of Defence Receipts.


Ref: HQrs office letter No. A/III/12157/MRO/PC-IV dated 21.12.2018 and letter No. A/III/12157/MRO/PC-IV dated 10.06.2019.

It has been observed that the percentage of transactions carried out through portal is still significantly lower w.r.t. total transactions reported by RBI during this period. It reflects that the Units/Individuals are still depositing the defence receipts in physical forms by presenting cheque/cash through banks.

2. The objective of commencing e-MRO Portal is to obviate the need from remittance of MROs in physical form. It is therefore requested, to review this aspect and necessary measures may be taken in this regard.

2. It is further requested that liaison may be made with Units/Formations under your jurisdiction to ensure that defence receipts are invariably processed through e-MRO portal only. Further, it may also be ensured that the sub-offices under your jurisdiction deposit defence receipts through e-MRO portal only. If required, necessary training for use of e-MRO Portal may also be provided to Defence Units and offices under your jurisdiction.


